Dear Parents/ Carers,

Extra-Curricular Clubs – Summer Term 2

Overleaf are extra-curricular clubs we will be providing next half term. Please select clubs for your child and return to school by **Tues 21st May**. We will not accept forms after this date due to being able to finalise and produce club registers. For a club to run, we need a minimum of 6 children.

Once forms have been returned, we will confirm your child's place via Ping. If there is a charge for the club, please pay via ParentPay once you have received your confirmation ping. If you wish to pay by cash, please ask the school office for a barcoded letter that can be used at a local shop offering PayPoint. Your child will not be allowed to attend the club until payment has been made. If we have to cancel a club at short notice, for example due to staff illness or severe weather, we will notify parents via Arbor or email. If your child no longer wishes to attend a club once started, refunds will not be given unless there are exceptional circumstances.

Pupil Premium
